Payments: All fees must accompany entry. No postdated checks will be accepted. Online or faxed entries must be paid in full within ten days of receipt or prior to the start of the show, whichever is first. Please make checks payable to CFA Gulf Shore Region. **PayPal Accepted: cfagsr@hotmail.com.** There will be no refund after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections before the closing date. **SHOW CLOSING MONDAY, FEBRUARY 12, 2024, 11PM CST.**

Show Hall: The show hall has heating or air conditioning as appropriate. Food will be available, no outside food allowed. No alcoholic beverages allowed. Smoking is not permitted in the show hall. The show hall is handicapped accessible. Exhibitors with handicaps are responsible for making their special needs known to the entry clerk.

Show Hours: Saturday & Sunday from 9:00am to 5:00pm or until judging is complete. Check-in is 7:30am to 8:30am. Exhibitors arriving late that have already been marked absent in the catalog will have to notify each ring that they are present. Entries (except kittens) may not be removed from the show hall prior to the completion of judging without the permission of the show manager.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Health: This is a non-vetted show. It is strongly advised that all entries be inoculated against feline panleukopenia, feline rhinotracheitis, calici viruses, and rabies. It is also strongly recommended that cats be tested and found negative for FeLV and FIV. All entries must be free of fleas, fungus, and ear mites. The show committee reserves the right to remove any cat or kitten from the show hall if suspected of having any of the above conditions until examined by a veterinarian at the owner's or agent's expense. Entries' claws must be clipped on all four feet. Declawed cats and kittens under the age of 4 months not permitted in the show hall.

Cages and Supplies: Single cage spots are 22"x22"x22" and double cage spots are 22"x22"x45". Bring your own enclosure! NO WIRE CAGES AVAILABLE. Security cage for single entry requires purchase of extra half cage. Benching requests made at time of entry will be honored when possible. Litter will be provided.

Liability: Reasonable care of cats and other property will be provided. However, the CFA Gulf Shore Region, Arkansas State Fairgrounds and SHOW HOTELS will not be liable for any loss or damage to a cat, exhibitor, or their personal property.

Airport: Clinton International Airport (LIT). LIT is about 5 miles from the show hall. All show hotels have airport shuttle service.

Household Pets: Contact Shayla Copas at hello@shaylacopas.com or 501-502-7429 with any questions or for additional information regard entering and exhibiting a Household Pet. Toygers, Serengetis, Savannahs, and Chausies are not permitted in the show hall, will not be benched, and the entry fee will not be refunded.
