### Seguin Hotel Info:

Early bookers can search online for rooms in Seguin,  
east side San Antonio, and New Braunfels. Be sure to check with  
individual hotels about their pet policies, as they may vary from  
location to location.

### FLY-IN:

San Antonio International Airport (SAT), approx. 45 minutes drive.  
Austin Bergstrom (AUS), approx. 1 hr. drive via toll road.

### DRIVING DIRECTIONS:

Traveling on I-10: Take Exit 609 (TX-123 BUS/Austin St.), turn  
South onto N. Guadalupe St. Turn right onto S. Austin St. and the  
coliseum will be on the right.

Traveling on I-35 from the North: Exit 204A (TX-123/TX-82) in San  
Marcos, stay on frontage road approx. .2 mile and turn South on  
TX-123. Take TX-123 BUS (Austin St.) to coliseum on right.

Alternate route bypassing Austin via TX-130 Toll Rd: Take TX-130  
(toll road) south to US 90 (I-10). Toll beginning in Georgetown and  
ending at I-10 approximately \$18.01 with TxTag or \$25.42 Pay By  
Mail. Turn West on US 90 (E. Kingsbury St.) to TX-123 BUS/N.  
Austin St. Turn south and continue to coliseum on right.

### Show Rules:

This is a CFA licensed show and all CFA show rules will be  
enforced. A copy of the show rules may be purchased from CFA. All  
entries in Championship (except Novice), Premiership (except  
Novice), registered Kittens, recorded Household Pets, and regis-  
tered cats competing as Household Pets with a Household Pet  
color class prefix will be scored for CFA awards. The Region  
reserves the right to add or substitute judges not named in the  
show flier should it become necessary.

### Cages and Supplies:

Exhibitors are responsible for providing their own benching  
enclosures. A standard single benching cage is 22"x22"x22"  
(Show Rule 5.01j); a double cage is 22"x 22"x45". If you do not  
have an enclosure, a "pop up" is available to purchase at the  
show for \$20.

Use of any enclosure requires payment of "extra half cage"  
fee for first entry. Alamo City Cat Club will waive that fee for  
subsequent odd-numbered entries (3rd, 5th, etc.).

Litter will be provided; bring your own litter pans, cat food  
and cat dishes.

**NOTE: Per show rule 10.05, No more than two kittens or  
one cat may be benched in a single space whether  
entered for exhibition or competition or benched for sale.**

**Show Hall:** Seguin Events Complex Coliseum, 950 S. Austin St.  
is a handicapped-accessible facility that is air-conditioned and  
heated. There will be a concession stand available for lunch. No  
outside food or beverages are allowed.

### Health Information:

This is a non-vetted show. It is strongly advised that all cats or kittens  
entered or present in the show hall be inoculated before entry by a  
licensed veterinarian against feline panleukopenia (formerly known as  
feline distemper or feline infectious enteritis), feline rhinotracheitis,  
caliciviruses and rabies. It is also strongly recommended that cats and  
kittens be tested and found negative for FeLV before entry. All entries  
must be free of fleas, ear mites, fungus, or any contagious or  
infectious illness. Claws of all entries must be clipped prior to bench-  
ing. Declawed cats are not permitted in the show hall. No kittens under  
the age of 4 months will be permitted in the show hall.

### Entry Information:

It is the exhibitor's responsibility to contact the Entry Clerk to  
confirm receipt of online entries. Neither the Entry Clerk nor Alamo  
City Cat Club will be responsible for entries lost due to communica-  
tion errors. Per show rule 6.21, all entries must be accompanied by  
proper entry fees. Entries must be paid in full within 10 days of  
receipt or prior to the show, whichever is first.
