#### FLY-IN:

Eisenhower National Airport (ICT), approx. 10-minute drive.

#### **DRIVING DIRECTIONS:**

Traveling on I-35 (Kansas Turnpike) from the North: Exit 50 to US-400 W/US-54 W (Kellogg Ave) and proceed west Exit Maize Road and continue on frontage road to S. 111th St. Turn right into the Cotillion driveway (behind the Peterbilt sign). Traveling on I-35 (Kansas Turnpike) from the South: Exit 42 to I-135/235 and follow the loop around the city. Exit US-400W/ US-54 W (Kellogg Ave) and proceed west. Exit Maize Road and continue on frontage road to S. 111th St. Turn right into the Cotillion driveway (behind the Peterbilt sign).

#### Vendors: Vendors are welcome to set up on Friday, January 31, 2025 from 1:00pm till 5:00pm.

#### Show Rules:

All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Wichita Cat fanciers reserves the right to add or substitute judges not named in the show flier should it become necessary.

Show Hall: The Cotillion Ballroom, 11120 W. Kellogg Ave, is a handicapped-accessible facility that is air-conditioned and heated. There will be a concession stand available for lunch.

#### **Cages and Supplies:**

Pop-up cages are available for purchase. A limited number of wire cages are also available for benching. Litter will be provided; bring your own litter pans, cat food and cat dishes.

NOTE: Per show rule 10.05, No more than two kittens or one cat may be benched in a single space whether entered for exhibition, competition, or benched for sale.

#### Health Information:

This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, caliciviruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fleas, ear mites, fungus, or any contagious or infectious illness. Claws of all entries must be clipped prior to benching. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall.

#### **Entry Information:**

It is the exhibitor's responsibility to verify that the Entry Clerk has received your entry. Neither the Entry Clerk nor Wichita Cat Fancy will be responsible for entries lost due to communication errors. Check your entry in ECAT to see if entry clerk has marked your entry as processed. Per show rule 6.21, all entries must be accompanied by proper entry fees. Submitted entries must be paid in full within 10 days of receipt or prior to the show, whichever is first. Make checks payable to WCF (Wichita Cat Fanciers). No substitutions will be accepted after the closing date. No refunds made once your entry is received or for failure to bench.

Liability: Wichita Cat Fanciers will take reasonable care to safeguard entries and the property of exhibitors. Neither the club nor The Cotillion Ballroom will be liable for any loss, damage, or injury. Each exhibitor will be responsible for any damages they cause to the property.
